GUIDELINES/ INSTRUCTIONS FOR STUDENTS HOUSE EXAMINATIONS (OCTOBER-2022)

- 1. The duration of the exam will be 1.5 hours.
- 2. The students must obtain at least 25% marks in each subject and 33% marks in aggregate of all subjects to be eligible to appear in final examinations.
- 3. In case the student is not able to fulfill the above mentioned condition, he/she would be required to pass in the conditional examination to be held in the month of November, 2022 otherwise the University roll number will not be issued. <u>Rs. 100 per paper</u> will also be charged from the students.
- 4. Students who will not appear in the House Exams without prior information to the Controller of Examinations would not be allowed to appear in the final examinations.

IN THE EXAMINATION HALL

- 1. The examination room shall open **15 minutes** prior to the scheduled time. No student will be allowed to enter the examination room after commencement of the examination.
- 2. If any student is found indulging in any unfair means, his/her answer sheet would be cancelled. No plea or request would be entertained after that. Also, a heavy fine will be imposed.
- 3. No student will be allowed to leave examination room before half time.
- 4. Only blue pen and pencil are allowed.
- 5. Answer sheet without signature of the student and the invigilator will not be evaluated.
- 6. Scientific calculators are not allowed.
- 7. Mobile phones/Bluetooth or any other electronic device will not be allowed in the examination Hall. If a student is found with any of them, a fine of Rs. 500/- will be charged on the spot.
